About the research

Why have I been invited?

We invite you to participate in this study because you are interested in experiencing the VRoar interface. This audio-reactive Virtual Reality (VR) interface encourages a performer to explore extended vocal techniques within an alternative visual aesthetic experience. We are interested in whether this can support creative vocal expression and whether the sound-responsive animated hand-drawn aesthetics in the VR scene affect immersion and wellbeing. To evaluate this, we have compiled survey questions to be completed before and after the VRoar experience.

What will I be asked to do?

You will be asked to try the VRoar and feedback on your experience.

Feedback takes the form of a survey. We expect the whole experience to take around 20 minutes.

About the surveys.

The surveys will be handed to you on the day. The total time required to complete the surveys is anticipated to be under 10 minutes.

The surveys do not require personal details such as your date of birth or postcode. They contain a mixture of "Yes/No" questions, some with a sliding scale, and some open questions for longer written answers.

The 'before and after' survey uses the *PANAS scale*; this is a questionnaire asking you about particular emotions and how much you felt each of them before and after the VR experience; this is so we can measure if there are any changes in well-being from experiencing the VRoar. There are some additional questions to answer in the 'after' survey. If there are any questions you don't want to answer, you can leave them blank.

What information about me will you collect and why?

On your consent form, you will provide your name and email address. This data will be kept separate from the survey data set but will allow us to remove it if you wish to withdraw consent within one month of taking the survey. After this date, the data set will be anonymised, and it will no longer be possible to withdraw consent.

It is for the purpose of research that we are collecting and storing this information, and we are storing it in accordance with data protection law which protect your rights. These state that we must have a legal basis (specific reason) for collecting your data.

How will my information be stored and how will you look after it?

The data is entered into an online system called Qualtrics. This is an authorised solution by MMU use Standard Contractual Clauses, which covers the restricted transfer of personal data to the USA. Qualtrics offer a good level of assurance and have been assessed to do so by MMU.

How will you use my information?

The information we collect using Qualtrics will be anonymised and unidentifiable. Participants will not be named in any of the research outputs. We will use the information to write journal articles, book chapters, and project reports.

Will my data be sent anywhere else or shared with other people or organisations?

In addition to the four people conducting the research, access will be granted to authorised representatives from the two universities to permit study-related monitoring, audits and inspections.

When will you destroy my information?

We will keep the anonymous data for up to 10 years from the end of the project to allow for publishing the results in peer-reviewed journals. Your personal information will be deleted at the end of the project.

Data Protection Law

Data protection legislation requires that we state the 'legal basis' for processing information about you. In the case of research, this is 'a task in the public interest.' If we use more sensitive information about you, such as information about your health, religion, or ethnicity (called 'special category' information), our basis lies in research in the public interest. Manchester Metropolitan is the Controller and Edge Hill University is the joint controller for this information and are jointly responsible for looking after your data and using it in line with the requirements of the data protection legislation applicable in the UK.

Under UK law, you have the right to make choices about your information. If you have any questions or would like us to do something with your information, you can ask the researcher Adinda van 't Klooster or someone else at the University. Contact details are shown towards the bottom of this document.

You can stop being a part of the study at any time without giving a reason. You can ask us to delete your data at any time, but it might not always be possible. If you ask us to delete information within one month of participating in the evaluation, we will ensure this is done. If you ask us to delete data after this point, we might not be able to do so. If your data is anonymised (where we take out your name and any other information that lets us know the information is about you), we will not be able to delete it because we will not know which data is yours.

Who has reviewed this research project?

Do I have to take part?

No, participation is entirely voluntary. It is up to you to decide whether to participate in this research. If you choose not to participate in this research, you don't need to complete the evaluation. If you decide to take part, you are still free to withdraw within one month of taking the survey without giving a reason and without detriment to yourself. Are there any risks if I participate?

Some people are sensitive to VR and may experience short-lasting headaches or motion sickness. If this is the case, you should stop immediately. Most people don't experience these symptoms when doing VR for a short period of time.

Are there any advantages if I participate?
